

ABOS KSB Requirement

- Beginning academic year 2025/26: July 1, 2025
- **Participation is required**, not specific levels of achievement
- Resident must meet ABOS participation requirements





ABOS KSB Participation Requirements

Effective July 1, 2025, for Residents who wish to take the ABOS Part I Examination in July 2026:

• Knowledge

• PGY 1-5

3 OITE examinations completed

Surgical Skills

• PGY 2-5

80 completed assessments per year of residency education

• PGY 1

12 completed assessments

Professional Behavior

• PGY 2-5

6 completed end-of-rotation professional behavior assessments per year

• PGY 1

3 completed end-of-rotation professional behavior assessments



- Participation will be a requirement to sit for ABOS Part I



Purpose and Collaboration

The ABOS has collaborated with the Accreditation Council for Graduate Medical Education (ACGME) to integrate case log entry into the ABOS KSB web portal and mobile app. In one place, residents will be able to enter all of their case logs as required by the ACGME and concurrently request an ABOS KSB Surgical Skill Assessment. The ABOS will be rolling out this integrated platform portal so that all orthopaedic surgery residency programs will have access by 2025.

•Case log data are available for ADS reporting within 48 hours of entry.








Unexpected Pop Ups/Scenarios



If you are past 48 hours for Surgical Skills Request:

 Pop-up appears
 Uncheck box for KSB assessment
 Submit



If you modify a previously submitted cases (e.g. error)

Press Submit
 Changes
 Submitted to both
 ACGME and
 ABOS



Unexpected Pop Ups/Scenarios

"Your assessment request has NOT been sent to Dr. ABC. Please contact your residency program coordinator to add them as an attending in KSB+."

- Surgical Case was submitted to ACGME, but no surgical skill assessment submitted.
- Either program has not entered that individual in the KSB Faculty List or Duplicates in ADS system.

If a resident must rescind a Surgical Case submission (i.e.- case cancelled at last minute), find the incorrect submission, and simply "rewrite" over it with a new submission.

• There is no deleting surgical cases submitted, just the ability to over-write them and the ACGME/ABOS will receive the changes once they are submitted.





FAQs

- Is ABOS KSB Program replacing ACGME Case Logs?
 - No, this is a collaboration.
- Should residents enter all their ACGME Case Logs through the ABOS KSB Program?
 - Yes
- Are all residency programs required to participate?
 - Yes, if there are residents that wish to be ABOS Examination Candidates.
- How do Program Directors and Program Coordinators review ACGME Case Log Data?
 - Continue to use ACGME ADS Case Log System.
- Can a resident claim credit for more than one procedure done on a single patient on a single date via the ABOS KSB Platform?
 - Yes, in an identical fashion as was done in the ACGME ADS system. Residents must enter cases such as those that have two or more separate entries in the integrated platform.
- Who owns the data?
 - The data are owned by the ABOS. The ACGME Case Log data are owned by the ACGME.
- Do residents have to log a case within 48 hours?
 - If they want to request the corresponding ABOS KSB Surgical Skills assessment.
